8 **accept a grant from the Akron Community Foundation, for the period 1/1/19 through**
9 **12/31/20, in the amount of \$25,000.00, with no local cash match requirement, and**
10 **appropriating funds, for the Executive's Department of Job and Family Services for Fiscal**
11 **Year 2019, and declaring an emergency.**

13 WHEREAS, the Akron Community Foundation has awarded a grant to the Executive's
14 Department of Job and Family Services, for the period 1/1/19 through 12/31/20, in the amount of
15 \$25,000.00, with no local cash match requirement; and

17 WHEREAS, the funding will provide certified instructors for fatherhood
18 classes/workshops and to provide related supportive services to attendees for the Summit County
19 Fatherhood Initiative; and

21 WHEREAS, it is necessary to appropriate said grant funds for Fiscal Year 2019;

23 WHEREAS, this Council finds and determines after reviewing all pertinent information
24 that it is necessary and in the best interest of the County of Summit to authorize the County
25 Executive to execute any documents necessary to accept a grant from the Akron Community
26 Foundation, for the period 1/1/19 through 12/31/20, in the amount of \$25,000.00, with no local
27 cash match requirement, and appropriating funds;


