An Ordinance amending Section 755.03 of the Codified Ordinances of the County of					

An Ordinance amending Section 755.03 of the Codified Ordinances of the County of Summit, entitled "License Applications; Requirements," to require background checks by the Ohio Bureau of Criminal Identification and Investigation for managers, supervisors and all other employees of entertainment device arcades, for the Executive's Department of Law and Risk Management-Office of Consumer Affairs, and declaring an emergency.

WHEREAS, County Council adopted Ordinance 2010-160, which enacted Chapter 755 of the Codified Ordinances of the County of Summit, entitled "Entertainment Device Arcades," for the purpose of regulating skill-based amusement games, internet café terminals and internet sweepstakes machines in the unincorporated areas of the County; and

WHEREAS, Council subsequently adopted Ordinance Nos. 2010-262, 2011-072 and 2017-132, which amended Section 755.03 of the Codified Ordinances of the County of Summit, entitled "License Application; Requirements;" to set forth the requirements for a license for an entertainment device arcade; and

WHEREAS, the County wishes to amend Section 755.03 to require background checks by the Ohio Bureau of Criminal Identification and Investigation ("Ohio BCI") for managers, supervisors and all other employees of entertainment device arcades to further protect the public; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to amend Section 755.03 to require background checks by the Ohio BCI for managers, supervisors and all other employees of entertainment device arcades:

NOW THEREFORE, BE IT ORDAINED, by Council of the County of Summit, State of Ohio, that:

SECTION 1

Section 755.03 of the Codified Ordinances of the County of Summit, entitled "License Application; Requirements" is hereby amended as set forth on Exhibit A, attached hereto and incorporated herein by reference.

SECTION 2

This Ordinance is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately require background checks by the Ohio Bureau of Criminal Identification and Investigation for managers, supervisors and all other employees of entertainment device arcades to protect the public.
