A Resolution confirming an award by the Board of Control of a renewal (second of five) of a professional service contract with Keefe Commissary Network, LLC, to operate the Jail Inmate Commissary, for a one-year term, from 11/15/19 through 11/14/20, with a commission rate of 38% to be paid to the County, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2017-441, which confirmed the award by the Board of Control of a professional service contract with Keefe Commissary Network, LLC, to operate the Jail Inmate Commissary, for a one-year term, from 11/15/17 through 11/14/18, with five options to renew for an additional one-year term, with a commission rate of 38% to be paid to the County; and

WHEREAS, the Board of Control, at its meeting on November 27, 2019, awarded a renewal (second of five) of a professional service contract with Keefe Commissary Network, LLC, to operate the Jail Inmate Commissary, for a one-year term, from 11/15/19 through 11/14/20, with a commission rate of 38% to be paid to the County, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned renewal of a professional service contract with Keefe Commissary Network, LLC is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
