WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with Barbicas Construction Co., Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

The award by the Board of Control of a construction contract with Barbicas Construction Co., Inc. for the resurfacing and improvement of Portage Lakes Dr., in Council District 8, in an amount not to exceed \$372,968.75, is hereby confirmed and the County Executive is hereby authorized to execute such construction contract and any other necessary related documents.

## **SECTION 2**

This Resolution is declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to immediately confirm the award of a necessary construction contract to allow for the resurfacing and improvement of Portage Lakes Dr. to begin as expeditiously as possible.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

## **SECTION 4**

It is found and determined that all formal actions of the Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
