A Resolution confirming an award by the Board of Control of a construction contract with J.D. Williamson Construction Co., Inc. for the rehabilitation of the Riverview Bridge in Cuyahoga Falls, in Council District 3, in an amount not to exceed \$1,239,851.13, for the Engineer, and declaring an emergency.

WHEREAS, the Board of Control, at its November 27, 2019 meeting, awarded a construction contract with J.D. Williamson Construction Co., Inc. for the rehabilitation of the Riverview Bridge in Cuyahoga Falls, in Council District 3, in an amount not to exceed \$1,239,851.13, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with J.D. Williamson Construction Co., Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## **SECTION 1**

The award by the Board of Control of a construction contract with J.D. Williamson Construction Co., Inc. for the rehabilitation of the Riverview Bridge in Cuyahoga Falls, in Council District 3, in an amount not to exceed \$1,239,851.13, is hereby confirmed and the County Executive is hereby authorized to execute such construction contract and any other necessary related documents.

## **SECTION 2**

This Resolution is declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to immediately confirm the award of a necessary construction contract to rehabilitate the Riverview Bridge to begin as expeditiously as possible.

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

## **SECTION 4**
