A Resolution authorizing the County Executive to finalize and pay the County's contribution under the Cooperative Agreement with the City of Akron, Scalan, LLC, Mellow Yellow Properties, LLC, and Pleasant Valley Construction Company for the development of the Firestone Business Park, by an amount in excess of the amount estimated in said agreement, for a total amount not to exceed \$482,813.00, towards the cost of the Electric Utility Infrastructure associated with the development of the Firestone Business Park, located in the City of Akron, in Council District 5, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2018-501, which authorized the County Executive to execute a Cooperative Agreement with the City of Akron, Scalan, LLC, Mellow Yellow Properties, LLC, and Pleasant Valley Construction Company for the development of the Firestone Business Park ("Cooperative Agreement"), located in the City of Akron, in Council District 5; and

WHEREAS, in accordance with Section 3.7(c) of the Cooperative Agreement, the County's contribution towards the cost of the Electric Utility Infrastructure for the Firestone Business Park (the "Project") was memorialized as an estimated total amount not to exceed \$325,000.00; and

WHEREAS, due to unknown underground structures and soil conditions, which negatively impacted the electrical installation cost for the Project, the County's contribution towards the cost of the Project is expected to exceed the initial contribution amount of \$325,000.00 by an additional \$157,813.00, for a total amount not to exceed \$482,813.00; and

WHEREAS, it is necessary for this Council to authorize the increase of the County's Contribution towards the cost of the Project by an additional \$157,813.00, for a total amount not to exceed \$482,813.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary, and in the best interest of the County of Summit to authorize the County Executive to increase the County's contribution towards the cost of the Project in a total amount not to exceed \$482,813.00;
