7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award by the Ohio Department of Rehabilitation and Correction's Office of**
9 **Justice Programs of a Reentry Court Program Enhancement Drug Court for a project**
10 **period from 10/1/19 through 9/30/22, in the amount of \$455,471.00, with no local cash**
11 **match requirement, for the Court of Common Pleas-General Division, and declaring an**
12 **emergency.**

14 WHEREAS, the Ohio Department of Rehabilitation and Correction's Office of Justice
15 Programs ("ODRC-OJP") has awarded the Court of Common Pleas-General Division a Reentry
16 Court Program Enhancement Drug Court Grant for a project period from 10/1/19 through
17 9/30/22, in the amount of \$455,471.00, with no local cash match requirement, for the operation
18 of its Reentry Court; and

20 WHEREAS, the Reentry Court services individuals who have been granted judicial
21 release by using a systematic approach for successful reintegration of said individuals into
22 society through treatment and access to local services; and

24 WHEREAS, the ODRC-OJP Adult Drug Court Discretionary Grant Program provides
25 financial and technical assistance to courts such as the Reentry Court; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is
28 necessary and in the best interest of the County of Summit to authorize the Executive to execute
29 any documents necessary to accept the award from the ODRC-OJP of the aforementioned
30 Reentry Coalition Grant;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is hereby authorized to execute any documents necessary to accept
38 an award by the Ohio Department of Rehabilitation and Correction's Office of Justice Programs
39 ("ODRC-OJP") of a Reentry Court Program Enhancement Drug Court for a project period from
40 10/1/19 through 9/30/22, in the amount of \$455,471.00, with no local cash match requirement.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the citizens of the County of Summit, and for the further reason to immediately
46 authorize the acceptance of the award by ODRC-OJP the Reentry Court Program Enhancement
47 Drug Court so that the grant funds to be immediately used.


