7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Cavanaugh Building Corporation for the Summit County Sheriff Training Facility Storage**
9 **Building Expansion, in Council District 8, in an amount not to exceed \$153,500.00, for the**
10 **Executive's Department of Administrative Services-Physical Plants Division, and declaring**
11 **an emergency.**

13 WHEREAS, the Board of Control, at its November 6, 2019 meeting, awarded a
14 construction contract with Cavanaugh Building Corporation for the Summit County Sheriff
15 Training Facility Storage Building Expansion, in Council District 8, in an amount not to exceed
16 \$153,500.00, subject to confirmation by County Council; and

18 WHEREAS, this Council previously adopted Resolution 2019-048, approving the Capital
19 Improvement Program for the period 2019-2024; and

21 WHEREAS this Council finds and determines, after reviewing all pertinent information,
22 that the aforementioned construction contract with Cavanaugh Building Corporation is necessary
23 and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The award by the Board of Control of a construction contract with Cavanaugh Building
31 Corporation for the Summit County Sheriff Training Facility Storage Building Expansion, in
32 Council District 8, in an amount not to exceed \$153,500.00, is hereby confirmed and the County
33 Executive is hereby authorized to execute said construction contract and any necessary related
34 documents.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the residents of the County of Summit, and for the further reason that it immediately
40 provides for construction of a necessary expansion of the Summit County Sheriff Training
41 Facility Storage Building.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
