A Resolution authorizing the County Executive to execute any documents necessary to accept a Fiscal Year 2019 Emergency Management Performance Grant of federal reimbursement funds from the State of Ohio Department of Public Safety, Emergency Management Agency, for the period 10/1/18 through 9/30/20, in the amount of \$181,726.00, and authorizing the expenditure of \$181,726.00 for the County's 50% local cash match requirement, for the Executive's Department of Law and Risk Management – Division of Public Safety/Emergency Management Agency, and declaring an emergency.

WHEREAS, the State of Ohio Department of Public Safety, Ohio Emergency Management Agency ("OEMA"), has awarded the County of Summit Emergency Management Agency ("SCEMA") a Fiscal Year 2019 Emergency Management Performance grant for the period 10/1/18 through 9/30/20, in the amount of \$181,726.00 in federal funds, as reimbursement for operational activities with the cost-share, cash-match requirement that an equal amount of operational activities be paid by the County of Summit with non-federal funds; and

WHEREAS, County Council previously adopted Resolution No. 2018-500, which approved the 2019 annual operating budget for the County of Summit, including \$630,200.00 for the Emergency Management Agency's operational activities which will fulfill grant requirements for matching and reimbursements; and
