7 **A Resolution authorizing the County Executive to execute agreements for the acquisition of**
8 **standard highway easements and temporary easements as part of the Wright Road Bridge**
9 **over Pigeon Creek Replacement Project, located in Copley Township, in Council District 5,**
10 **in a total amount not to exceed \$2,136.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, there is a public need to replace the Wright Road Bridge over Pigeon Creek,
13 and the County intends to undertake the Wright Road Bridge over Pigeon Creek Replacement
14 Project, located in Copley Township, in Council District 5 (the "Project"); and

15
16 WHEREAS, certain land must be acquired by the County to be utilized as public rights-
17 of-way as part of the Project; and

18
19 WHEREAS, acquisition of lands for public rights-of-way for the Project is considered a
20 local cost, which must be borne in whole by the local public agency performing the Project, in
21 this case being the County of Summit; and

23 WHEREAS, the County has negotiated terms for agreements for the acquisition of
24 standard highway easements and temporary easements with six property owners in Copley
25 Township, in Council District 5, to serve as the necessary public rights-of-way for the Project;
26 and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to authorize the County
30 Executive to execute the aforementioned agreements for the acquisition of standard highway and
31 temporary easements;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that;

38 The County Executive is hereby authorized to execute agreements for the acquisition of
39 standard highway easements at the below listed addresses, in Copley Township, in Council
40 District 5, in a total amount not to exceed \$2,136.00, as part of the Wright Road Bridge over
41 Pigeon Creek Replacement Project, with the owners of said property, and in the amounts as
42 follows:


