WHEREAS, the County Executive desires to enter into an intergovernmental governmental agreement and related necessary documents with the Ohio Department of Transportation ("ODOT") for the sale of a portion of County real property (Parcel Nos. 6708887 and 6709658), which is the location of the County Engineer's Main Office at 538 East South St., Akron, Ohio 44311, in Council District 4, for a total amount of \$655.00; and

WHEREAS, as depicted as depicted in Exhibit A attached hereto, the sale will consist of a warranty deed for a portion of County real property "11-WD," for payment by ODOT in the amount of \$615.00, and a temporary easement, "11-T," for payment by ODOT in the amount of \$40.00; and

WHEREAS, the aforementioned real property is needed by ODOT for the reconfiguration of the Central Interchange (I-77 at I-76 at SR 8) project; and
