7 **A Resolution confirming an award by the Board of Control of Change Order No. 1, to a**  
8 **professional service contract with Child Guidance and Family Solutions, for intervention**  
9 **services for youth with behavioral problems, in an amount not to exceed \$145,000.00, (a**  
10 **cumulative increase of 145%), for a total amount not to exceed \$245,000.00, for the**  
11 **Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its September 18, 2019 meeting, awarded Change  
14 Order No. 1, to a professional service contract with Child Guidance and Family Solutions, for  
15 intervention services for youth with behavioral problems, in an amount not to exceed  
16 \$145,000.00, (a cumulative increase of 145%), for a total amount not to exceed \$245,000.00; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that Change Order No. 1 to a professional service contract with Child Guidance and Family  
20 Solutions, is necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
23 of Ohio, that:

27 Change Order No. 1, to a professional service contract with Child Guidance and Family  
28 Solutions, for intervention services for youth with behavioral problems, in an amount not to  
29 exceed \$145,000.00, (a cumulative increase of 145%), for a total amount not to exceed  
30 \$245,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
31 change order and any necessary related documents.

33 SECTION 2

35 This Resolution is declared an emergency in the interest of the health, safety and welfare  
36 of the citizens of the County of Summit and for the further reason to immediately confirm the  
37 award of a necessary change order to the professional service contract so that services for clients  
38 are provided.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take  
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of the Council concerning and relating  
49 to the adoption of the Resolution were adopted in an open meeting of this Council, and that all  
50 deliberations of this Council and of any of its committees that resulted in such formal action,  
51 were in meetings open to the public, in compliance with all legal requirements, including Section  
52 121.22 of the Ohio Revised Code.


