7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Public Safety, through the Ohio Traffic**
9 **Safety Office, of a grant for a countywide Operating a Motor Vehicle While Intoxicated**
10 **Task Force Program, for the period 10/1/19 through 9/30/20, in the amount of \$225,000.00,**
11 **with no local cash match requirement, to execute intergovernmental purchase contracts**
12 **and any other documents necessary to authorize payments to various law enforcement**
13 **agencies participating in the Task Force, for services provided during the grant period, in**
14 **an aggregate amount not to exceed \$143,310.65, and appropriating said grant funds, for the**
15 **Sheriff, and declaring an emergency.**

17 WHEREAS, the Ohio Department of Public Safety, through the Ohio Traffic Safety
18 Office, has awarded the County Sheriff a grant of federal funds for a countywide Operating a
19 Motor Vehicle While Intoxicated (“OVI”) Task Force Program for the period 10/1/19 through
20 9/30/20, in the amount of \$225,000.00, with no local cash match requirement in order to conduct
21 high visibility enforcement, public awareness, and education for alcohol-related crashes and
22 traffic-related fatalities in the County of Summit; and

24 WHEREAS, it is further necessary to authorize the County Executive to execute
25 intergovernmental purchase contracts and any other related documents necessary to authorize
26 payments to various law enforcement agencies participating in the OVI Task Force for services
27 provided during the grant period, in an amount not to exceed \$143,310.65; and

29 WHEREAS, pursuant to Section 177.21 of the Codified Ordinances of the County of
30 Summit, the approval of County Council is required for said intergovernmental purchase
31 contracts; and

33 WHEREAS, it is necessary and in the best interest of the County of Summit to
34 appropriate all said grant funds for the period 10/1/19 through 12/31/19; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that it is necessary and in the best interest of the County of Summit to authorize the County
38 Executive to execute any documents necessary to accept the aforementioned grant for the OVI
39 Task Force, to execute the aforementioned intergovernmental purchase contracts and any other
40 necessary related documents authorizing payments to various law enforcement agencies
41 participating in the Task Force and to appropriate said grant funds;

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State


