A Resolution approving and authorizing the County Executive to execute Community Development Block Grant contracts with the Village of Lakemore and the Western Reserve Community Fund, in a total amount not to exceed \$265,000.00, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, the County receives Community Development Block ("CDBG") grant funds from the U.S. Department of Housing and urban development to assist low to moderate income individuals and/or low to moderate income areas; and

WHEREAS, the County wishes to enter into a CDBG contract with the Village of Lakemore to fund the cost of a waterline on Sanitarium Road for Restore Addiction Recovery, in an amount not to exceed \$165,000.00; and

WHEREAS, the County wishes to enter into a CDBG contract with the Western Reserve Community Fund, to capitalize existing loan funds for economic development, in an amount not to exceed \$100,000.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute CDBG contracts with the Village of Lakemore and the Western Reserve Community Fund, in a total amount not to exceed \$265,000.00;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

The County Executive is hereby authorized to execute CDBG contracts with the Village of Lakemore to fund the cost of a waterline on Sanitarium Road for Restore Addiction Recovery, in an amount not to exceed \$165,000.00, and with the Western Reserve Community Fund in an amount not to exceed \$100,000.00.

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit and for the further purpose to immediately authorize the County to provide financial assistance to the Village of Lakemore and the Western Reserve Community Fund, for the aforementioned necessary projects.
