A Resolution declaring the month of September 2019 as Preparedness Month in Summit County, promoting family and community disaster and emergency planning for the residents of Summit County, for the Executive, and declaring an emergency.

WHEREAS, Summit County leaders recognize no community is immune from the threat of disaster; and

WHEREAS, September is recognized as National Preparedness Month; and

WHEREAS, the County of Summit, Division of Public Safety and Emergency Management Agency are dedicated to ensuring residents of Summit County are prepared in the face of possible emergencies and disasters through educational programs, planning activities and other resources; and

WHEREAS, through these programs, Summit County residents can be more resilient in the event of an emergency; and

WHEREAS, Summit County residents are encouraged to enroll in Summit County's Reverse Alert Program to actively prepare for emergency; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit that September 2019 be declared Preparedness Month in Summit County, promoting family and community disaster and emergency planning for the residents of Summit County;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

### SECTION 1

The month of September 2019 is hereby declared Preparedness Month in Summit County.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents and employees of the County of Summit and for the further purpose of immediately declaring September 2019 as Preparedness Month in Summit County.

### **SECTION 3**

Provided this Resolution receives the affirmative vote of eight (8) members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be in force at the earliest time provided by law.
