7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award by the Ohio Department of Rehabilitation and Correction, Division of**  
9 **Parole and Community Sanctions, of a Justice Reinvestment and Incentive Grant, with a**  
10 **period to expend the funds through 6/30/21, in the amount of \$168,440.00, with no local**  
11 **cash match requirement, and appropriating said grant funds, for the Court of Common**  
12 **Pleas-General Division, Adult Probation, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Rehabilitation and Correction, Division of Parole  
15 and Community Sanctions has awarded Justice Reinvestment and Incentive Grant (“JRIG”)  
16 funds in the amount of \$168,440.00 to the Court of Common Pleas-General Division, Adult  
17 Probation, to help support the adoption of policies and practices based on research, on how to  
18 reduce the number of offenders on probation supervision who violate the conditions of their  
19 supervision, with a period to expend the funds through 6/30/21, with no local cash match  
20 requirement; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to authorize the County  
24 Executive to execute any documents necessary, to accept funds from the Ohio Department of  
25 Rehabilitation and Correction, Division of Parole and Community Sanctions as set forth above,  
26 and to appropriate the same;

33 The County Executive is hereby authorized to execute any documents necessary, to  
34 accept an award by the Ohio Department of Rehabilitation and Correction, Division of Parole  
35 and Community Sanctions, of a Justice Reinvestment and Incentive Grant, with a period to  
36 expend the funds through 6/30/21, in the amount of \$168,440.00.
