7 **A Resolution confirming an award by the Board of Control of professional service**
8 **contracts with certain providers for the State Fiscal Year 2020 Temporary Assistance to**
9 **Needy Families program, from 10/1/19 through 9/30/20, in a total amount not to exceed**
10 **\$2,197,600.00, for the Executive's Department of Job and Family Services, and declaring**

13 WHEREAS, the Board of Control, at its meeting held July 31, 2019, awarded
14 professional service contracts with certain providers for the State Fiscal Year 2020 Temporary
15 Assistance to Needy Families program, from 10/1/19 through 9/30/20, in a total amount not to
16 exceed \$2,197,600.00, subject to confirmation by County Council; and

18 WHEREAS, a list of providers is set forth in Exhibit A, attached to this Resolution; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information
21 that the aforementioned professional service contracts with certain providers set forth in Exhibit
22 A are necessary and in the best interest of the County of Summit;

29 The award by the Board of Control of professional service contracts with certain
30 providers, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully
31 restated, for the State Fiscal Year 2020 Temporary Assistance to Needy Families
32 program, from 10/1/19 through 9/30/20, in a total amount not to exceed \$2,197,600.00, is
33 hereby confirmed and the County Executive is hereby authorized to execute such professional
34 service contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the residents of the County of Summit, and for the further reason to immediately
40 authorize the County Executive to execute the aforementioned professional service contracts in
41 order to enable to providers to provide necessary services as expeditiously as possible.
