8 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**
9 **with the City of Akron whereby the County will reimburse the City for 50% of the cost of**
10 **services provided by an individual to operate a joint 2020 Census Campaign, for a total**
11 **cost to the County in an amount not to exceed \$15,000.00, for the Executive, and declaring**
12 **an emergency.**

14 WHEREAS, the City of Akron and the County are co-sponsoring a 2020 Census
15 Campaign project in Summit County, Ohio in order to promote, market, and otherwise maximize
16 local engagement in the 2020 federal census; and

17
18 WHEREAS, the City intends to enter into a services agreement with an individual to
19 operate the joint 2020 Census Campaign for a total amount not to exceed \$30,000.00; and.

21 WHEREAS, the City has requested that the County enter into an intergovernmental
22 agreement with the City whereby the County will reimburse the City for 50% of the cost of the
23 aforementioned services, for a total cost to the County in an amount not to exceed \$15,000.00;

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County to authorize the County Executive to
28 execute the aforementioned intergovernmental agreement;

30 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to execute an intergovernmental agreement
36 with the City of Akron whereby the County will reimburse the City for 50% of the cost of
37 services provided by any individuals to operate a joint 2020 Census Campaign, for a total cost to
38 the County in an amount not to exceed \$15,000.00.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the residents of the County of Summit, and for the further reason to immediately
44 authorize the execution of said intergovernmental agreement in order to be prepared to timely
45 operate a 2020 Census Campaign.

9 effect and be in force at the earliest time provided by law.


