A Resolution approving the detailed plans, specifications, estimate of cost in an amount not to exceed \$96,000.00, and tentative assessment amount for the Valley View Homeowners' Association Sanitary Sewer Improvement Project Q-192, located in the City of Hudson, in Council District 3, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, the Valley View Homeowners' Association ("Parcel Owners") petitioned the County to construct the Valley View Homeowners' Association Sanitary Sewer Improvement Project Q-192 ("Improvement Project"), a copy of which is attached hereto as Exhibit A and incorporated herein by reference, whereby the County will take ownership of, and make necessary improvements to, the grinder pump, force main and appurtenances on or serving the Property Owner's parcels in order to abate a health nuisance; and

WHEREAS, under the authority of the Petition, and in accordance with Sections 6117.06 and 6117.28 of the Ohio Revised Code, the County may proceed with construction of the Improvement Project without further notices or hearings; and

WHEREAS, pursuant to the Petition, the four parcels owned by the Parcel Owners will be assessed in an estimated amount of \$24,000 each; and

WHEREAS, the detailed plans, specifications, estimate of cost in an amount not to exceed \$96,000.00, and an estimated assessment in the amount of \$24,000.00 per parcel of the Improvement Project are on file in the Clerk of Council's Office; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, including the detailed plans, specifications, estimate of cost and an estimated assessment of the Improvement Project, that the Improvement Project is necessary for the preservation and promotion of the public health and welfare, and is in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

DECOLUTION NO

This Council hereby approves, and ratifies, the detailed plans and specifications for the construction of the Valley View Homeowners' Association Sanitary Sewer Improvement Project Q-192 ("Improvement Project"), the character and termini of the Improvement Project, and the boundaries of the assessment district as further described in Exhibit B, which is attached hereto and incorporated herein as if fully rewritten, located in the City of Hudson, in Council District 3.

SECTION 2

This Council declares that the Improvement Project is necessary for the preservation and promotion of the public health and welfare.

SECTION 3

This Council approves the tentative total cost for the Improvement Project, in an amount not to exceed \$96,000.00.

SECTION 4

This Council determines that special assessments shall be levied and collected to pay the cost of the Improvement Project.

SECTION 5

The estimated assessment for the Improvement Project in the amount of \$24,000.00 per parcel, which will be specially assessed against the benefited properties, as further detailed in Exhibit C, which is attached hereto and incorporated herein as if fully rewritten, is hereby approved and ratified by this Council. The estimated assessment is for the information of property owners and shall not be levied or certified to the County's Fiscal Officer for collection.

SECTION 6

This Council determines that the Improvement Project, in accordance with the plans and specifications provided for the Improvement Project as herein approved and ratified, shall proceed to construction.

SECTION 7

This Resolution is declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to provide for the immediate construction of the Improvement Project in the City of Hudson needed to abate a health nuisance.

SECTION 8

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 9

It is found and determined that all formal actions of the Council concerning and relating to the adoption of the Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
