A Resolution confirming an award by the Board of Control of a renewal (first of two) of a professional service contract with Wichert Insurance Services, Inc. dba Wichert Insurance, to provide brokerage services for the County's property, liability and boiler and machinery insurance program, and to provide Claim Reporting Services using Riskmaster, for a one-year term, from 7/1/19 through 6/30/20, in an amount not to exceed \$45,000.00, and amending Resolution No. 2018-214 to provide for two options to renew said contract for an additional one-year term, for the Executive's Department of Law and Risk Management, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2018-214, which confirmed an award by the Board of Control of a professional service contract with Wichert Insurance Services, Inc. dba Wichert Insurance, ("Wichert") to provide brokerage services for the County's property, liability and boiler and machinery insurance program, and to provide Claim Reporting Services using Riskmaster, for a one-year term, from 7/1/18 through 6/30/19, in an amount not to exceed \$45,000.00; and

WHEREAS, Board of Control Directive No. 168-18 provides for two options to renew for an additional one-year term, which should have been included in Resolution No. 2018-214, requiring its amendment; and

WHEREAS, the Board of Control, at its meeting held June 12, 2019, awarded a renewal (first of two) of a professional service contract with Wichert to provide brokerage services for the County's property, liability and boiler and machinery insurance program, and to provide Claim Reporting Services using Riskmaster, for a one-year term, from 7/1/19 through 6/30/20, in an amount not to exceed \$45,000.00, subject to confirmation by County Council; and

WHEREAS, this Council previously adopted Resolution No. 2019-105, which confirmed an award by the Board of Control authorizing the purchase of contracts for liability, boiler and machinery, property, and other miscellaneous and necessary insurance coverage, for a one-year term, from 4/15/19 through 4/15/20, in an amount not to exceed \$923,431.00, payable through Wichert, as a Best Practical Source; and

WHEREAS, because Wichert will be directly paid in excess of \$900,000.00 pursuant to Resolution No. 2019-105, Council approval of the renewal (first of two) of the professional service contract with Wichert is necessary; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest in the County of Summit to amend Resolution 2018-241 to provide for two options to renew the professional service contract with Wichert for an additional one-year term and to confirm the award by the Board of Control of the aforementioned renewal (first of two) of said contract;

SECTION 1

Resolution No. 2018-241 is hereby amended to provide for two options to renew for an additional one-year term the professional service contract with Wichert Insurance Services, Inc. dba Wichert Insurance, ("Wichert") to provide brokerage services for the County's property, liability and boiler and machinery insurance program, and to provide Claim Reporting Services using Riskmaster, for a one-year term, from 7/1/18 through 6/30/19, in an amount not to exceed \$45,000.00.

SECTION 2

The award by the Board of Control of a renewal (first of two) of a professional service contract with Wichert to provide brokerage services for the County's property, liability and boiler and machinery insurance program, and to provide Claim Reporting Services using Riskmaster, for a one-year term, from 7/1/19 through 6/30/20, in an amount not to exceed \$45,000.00, is hereby confirmed and the Executive is hereby authorized to execute said renewal of such professional service contract.

SECTION 3

This Resolution is hereby declared to be an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit, and for the further reason to immediately provide brokerage services for the County's property, liability and boiler and machinery insurance and Claim Reporting Services using Riskmaster effective 7/1/19.

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
