7 **A Resolution increasing appropriations, in the amount of \$500,000.00, in various Fiscal**  
8 **Office funds, for the Fiscal Officer, and declaring an emergency.**

10 WHEREAS, the County Fiscal Office has had an increased amount of tax foreclosures  
11 from tax lien companies to process each month, which has increased the frequency of Sheriff  
12 sales, along with the County Fiscal Office's need to advertise for said sales; and

13  
14 WHEREAS, it is necessary for the County Fiscal Office to appropriate \$100,000.00 in  
15 funding to the Contract Services account for the cost of title work required for the Sheriff Sales,  
16 \$200,000.00 in funding to the Advertising/Printing account for legal advertising costs, and  
17 \$200,000.00 in funding to cover filing costs with the Clerk of Courts, for a total increase in  
18 appropriations of \$500,000.00; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that it is necessary and in the best interest of the County of Summit to increase appropriations, in  
22 the amount of \$500,000.00, in the aforementioned funds;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:
