WHEREAS, the County Executive recommends that the County amend and renew said purchase contract with AT&T, at WSCA pricing, for a month-to-month term, commencing 5/29/19 and terminating no later than 2/29/20, in an amount not to exceed \$288,000.00; and

WHEREAS, the Board of Control, at its 5/29/19 meeting, awarded, subject to the approval of the IT Board, the First Amendment and Renewal of a purchase contract with AT&T, at WSCA pricing, for wireless voice and data services, for a month-to-month term, commencing 5/29/19 and terminating no later than 2/29/20, in an amount not to exceed \$288,000.00; and

WHEREAS, because said amendment and renewal of the purchase contract with AT&T is at WSCA pricing, it is exempt from competitive bidding pursuant to Section 177.07(a)(11) of the Codified Ordinances of the County of Summit; and
