7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award from the State of Ohio Department of Rehabilitation and Correction,**
9 **through the Community Corrections Act, of a 407 grant for State Fiscal Years 2020-2021,**
10 **in the amount of \$2,478,224.00, with no local cash match requirement, for community**
11 **corrections programs to be operated by the Summit County Adult Probation Department**
12 **and Oriana House, Inc., for the period 7/1/19 through 6/30/21, and appropriating grant**
13 **funds, for the Executive's Department of Law and Risk Management – Division of Public**
14 **Safety, and declaring an emergency.**

16 WHEREAS, the State of Ohio Department of Rehabilitation and Correction (ODRC),
17 through the Community Corrections Act ("CCA") grant program, has renewed the award to the
18 County of Summit of a 407 grant for State Fiscal Years 2020-2021, the period 7/1/19 through
19 6/30/21, in the amount of \$2,478,224.00, with no local cash match requirement, for community
20 corrections programs to be operated by the Summit County Adult Probation Department and
21 Oriana House, Inc., for the period 7/1/19 through 6/30/21; and

23 WHEREAS, it is necessary for the County Executive to execute documents necessary to
24 accept the grant award and to appropriate grant funds; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute any documents necessary to accept the CCA 407 grant funds in the amount of
29 \$2,478,224.00, with no local cash match requirement, for State Fiscal Years 2020-2021, and to
30 appropriate grant funds;
