7 **A Resolution authorizing the County Executive to advertise for bids for fourteen personal**
8 **radiation devices, for an estimated total cost not to exceed \$63,000.00, for the Executive's**
9 **Department of Law and Risk Management – Division of Public Safety, and declaring an**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for fourteen personal
16 radiation devices, for an estimated total cost not to exceed \$63,000.00; and

18 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that is necessary and in the best interest of the County of Summit to authorize the Executive to
23 advertise for bids for personal radiation devices;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is authorized to advertise for bids for fourteen personal radiation
31 devices, for an estimated total cost not to exceed \$63,000.00.

35 This Resolution is declared an emergency in the interest of the health, safety, and welfare
36 of the residents of the County of Summit, and for the further reason that it authorizes the
37 Executive to immediately advertise for bids for personal radiation devices in order to procure the
38 necessary equipment within the grant performance period.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.
