7 **An Amended Resolution authorizing the County Executive to advertise for bids for the**
8 **construction of Indian Creek Exposed Sewers Project Q-180 - Contract 2, located in the**
9 **City of Macedonia, in Council District 1, for an estimated total cost not to exceed**
10 **~~\$415,914.00~~ \$569,140.00, for the Executive's Department of Sanitary Sewer Services, and**
11 **declaring an emergency.**

13 WHEREAS, the County Executive wishes to advertise for bids for the construction of
14 Indian Creek Exposed Sewers Project Q-180 – Contract 2 (“Project”), located in the City of
15 Macedonia, in Council District 1, for an estimated total cost not to exceed ~~\$415,914.00~~
16 \$569,140.00, whereby the County will line two sections of the exposed sanitary sewers that cross
17 at Macedonia’s Indian Creek; and

19 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
20 requires this Council’s authorization for the County to advertise for bids for construction
21 contracts in excess of \$50,000.00; and

23 WHEREAS, a copy of the plans and specifications for the Project are on file with the
24 Clerk of Council; and

26 WHEREAS, the Department of Sanitary Sewer Services Sewer Enterprise Fund will fund
27 the Project; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary, and in the best interest of the County to authorize the County Executive to
31 advertise for bids for the construction of the aforementioned Project, for an estimated total cost
32 not to exceed ~~\$415,914.00~~ \$569,140.00;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The County Executive is hereby authorized to advertise for bids for the construction of
40 Indian Creek Exposed Sewers Project Q-180 - Contract 2 (“Project”), located in the City of
41 Macedonia, in Council District 1, for an estimated total cost not to exceed ~~\$415,914.00~~
42 \$569,140.00.

46 This Resolution is declared an emergency in the interest of the health, safety and welfare
47 of the residents of the County of Summit, and for the further reason to immediately advertise for
48 bids for the construction of the Project so that it may proceed in a timely manner.

53 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
54 effect and be in force at the earliest time provided by law.


