7 **A Resolution authorizing the County Executive to execute, subject to the approval of the**
8 **Board of Control, a construction contract with Chagrin Valley Paving Inc. for the 2019**
9 **Summit County 441 (448) Resurfacing Program – North, in an amount not to exceed**
10 **\$1,725,669.25, for the Engineer, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2019-036, which authorized
13 the Engineer to advertise as needed for bridge engineering and construction projects, and
14 pavement maintenance projects, for the Engineer's 2019 Capital Improvements Program, and
15 federal and state funded projects, at an estimated cost not to exceed \$8,328,000.00; and

16
17 WHEREAS, following the receipt and review of bids, the County Executive has proposed
18 entering into a construction contract with Chagrin Valley Paving Inc. for the 2019 Summit
19 County 441 (448) Resurfacing Program - North, in an amount not to exceed \$1,725,669.25; and

21 WHEREAS, the authorization of the County Executive to execute the aforementioned
22 construction contract is subject to the approval of the Board of Control, prior to, or subsequent
23 to, the adoption of this Resolution; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the County
27 Executive to execute, subject to the approval of the Board of Control, the aforementioned
28 construction contract with Chagrin Valley Paving Inc.;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that;

35 The County Executive is hereby authorized to execute, subject to the approval of the
36 Board of Control, a construction contract with Chagrin Valley Paving Inc., for the 2019 Summit
37 County 441 (448) Resurfacing Program - North, in an amount not to exceed \$1,725,669.25.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the residents of the County of Summit, and for the further purpose to immediately
43 provide necessary pavement repairs.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
