A Resolution authorizing the County Executive to donate 14 Lenovo Yoga Laptops and related equipment and support purchased from MNJ Technologies Direct, Inc., at State Term pricing, for the amount of \$27,328.00, to the Legal Defenders Office of Summit County, Ohio Inc., for the Executive, and declaring an emergency.

WHEREAS, the County has formed the Summit County Public Defender Commission pursuant to Chapter 120 the Ohio Revised Code; and

WHEREAS, the Commission is responsible for providing legal defense services to certain indigent persons charged with the commission of crimes under the ORC, the Codified Ordinances of the County of Summit and various municipal ordinances within the boundaries of the County; and

WHEREAS, the Commission is authorized by Section 120.14 of the Ohio Revised Code to contract with a nonprofit organization to provide legal services to indigent persons; and

WHEREAS, pursuant to Resolution No. 2019-005, the Commission has entered into a contract, which the County Executive has also executed, with the Legal Defenders Office of Summit County, Ohio, Inc. ("Legal Defenders"), a nonprofit corporation, to provide legal representation to indigent persons on behalf of the Commission from 1/1/19 to 12/31/19, for an amount not to exceed \$619,500.00; and

WHEREAS, the Board of Control, at its April 24, 2019 meeting, awarded a purchase contract with MNJ Technologies Direct, Inc., at State Term pricing, for 14 Lenovo Yoga Laptops and related equipment and support, in an amount not to exceed \$27,328.00; and

WHEREAS, the County will purchase the aforementioned laptops and related equipment and support with the intent to donate said equipment to the Legal Defenders for use in the legal representation of indigent defendants; and

WHEREAS, the approval of County Council is required to donate said equipment and support to the Legal Defenders; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the donation of said laptops, related equipment and support to the Legal Defenders;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
