WHEREAS, sanitary sewer easements are needed for the Indian Creek Exposed Sewers Project (Q-180) ("Project"), located in the City of Macedonia, in Council District 1; and

WHEREAS, the County Executive desires to execute an agreement with William F. and Mary S. Hollifield, in the amount of \$2,264.00, to acquire an easement over their real property located at 8635 North Bedford Rd., Macedonia, Ohio 44056 and known as Permanent Parcel No. 3312626, as part of the Project; and
