7 **A Resolution confirming an award by the Board of Control of a purchase contract with RJ**  
8 **Beck Protective Systems, Inc., at GSA pricing, for the purchase of an alarm system for the**  
9 **City of Green Local School District, in an amount not to exceed \$145,028.27, for the**  
10 **Sheriff, and declaring an emergency.**

11  
12 WHEREAS, the Board of Control, at its meeting held March 27, 2019, awarded a  
13 purchase contract with RJ Beck Protective Systems, Inc., as GSA pricing, for the purchase of an  
14 alarm system for the City of Green Local School District, in an amount not to exceed  
15 \$145,028.27, subject to confirmation by County Council; and

16  
17 WHEREAS, said purchase will be funded by a grant from the U.S. Department of Justice  
18 Community Oriented Policing Services School Violence Prevention Program Grant previously  
19 accepted by the County pursuant to Resolution No. 2018-457; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that the aforementioned purchase contract with RJ Beck Protective Systems, Inc. is necessary  
23 and in the best interest of the County of Summit;

25 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
26 of Ohio, that:

28 SECTION 1

30 The award by the Board of Control of a purchase contract with RJ Beck Protective  
31 Systems, Inc., at GSA pricing, for the purchase of an alarm system for the City of Green Local  
32 School District, in an amount not to exceed \$145,028.27, is hereby confirmed and the County  
33 Executive is hereby authorized to execute such purchase contract.

35 SECTION 2

37 This Resolution is hereby declared an emergency in the interest of the health, safety and  
38 welfare of the residents of the County of Summit, and for the further reason to immediately  
39 authorize the purchase of a necessary alarm system for the safety of students and teachers in the  
40 City of Green School District.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.

11 121.22 of the Ohio Revised Code.


