7 **A Resolution appropriating carryover Fiscal Year 2018 RECLAIM Ohio Grant funds, in**  
8 **the amount of \$1,295,392.34, for the Court of Common Pleas-Juvenile Division, and**  
9 **declaring an emergency.**

11 WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's  
12 overburdened juvenile justice system and allows local courts to target specific areas to divert  
13 youth from being institutionalized; and

14  
15 WHEREAS, County Council previously adopted Resolution No. 2018-235, which  
16 authorized to the County Executive to execute any documents necessary to accept the award by  
17 the Ohio Department of Youth Services of a State Fiscal Year 2019 RECLAIM Ohio Grant, for  
18 the period 7/1/18 to 6/30/19, in the estimated amount of \$5,162,120.69, with no local match  
19 requirement, and appropriated said grant funds; and

21 WHEREAS, the Ohio Department of Youth Services has certified carryover Fiscal Year  
22 2018 RECLAIM Ohio Grant funds, in the amount of \$1,295,392.34, and it is necessary to  
23 appropriate said carryover grant funds;

25 WHEREAS, this Council finds and determines after reviewing all pertinent information  
26 that it is necessary and in the best interest of the County of Summit to appropriate carryover  
27 Fiscal Year 2018 RECLAIM Ohio grant funds, in the amount of \$1,295,392.34;


