A Resolution authorizing the County Executive to execute an intergovernmental agreement with the City of Fairlawn to provide beds at the County Jail for City prisoners, at a maximum of two prisoners per day, for a term from 1/1/19 through 12/31/23, for a rate of \$123.55 per day per bed for the first year, with a rate increase not to exceed 2.5% per year for each of the subsequent years, for the Executive's Department of Law and Risk Management, and declaring an emergency.

WHEREAS, the County and the City of Fairlawn have negotiated an intergovernmental agreement pursuant to which the City may use beds in the County Jail to house City prisoners, at a maximum of two prisoners per day; and

WHEREAS, the City has agreed to pay a rate of \$123.55 per day per bed for the first year and a rate increase not to exceed 2.5% per year for each of the subsequent years; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that it is necessary and the best interest of the County of Summit to authorize the County Executive to execute the aforementioned intergovernmental agreement with the City of Fairlawn;

NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

RESOLUTION NO.

The County Executive is hereby authorized to execute an intergovernmental agreement with the City of Fairlawn to provide beds at the County Jail for City prisoners, at a maximum of two prisoners per day, for a term from 1/1/19 through 12/31/23, for a rate of \$123.55 per day per bed for the first year and a rate increase not to exceed 2.5% per year for each of the subsequent years, a copy of which is attached hereto as Exhibit A and incorporated fully herein, with such modifications and revisions as shall be in furtherance of the provisions of said intergovernmental agreement and not substantially adverse to the County, all of which shall be conclusively evidenced by the execution thereof by the County Executive.

SECTION 2

This Resolution is hereby declared an emergency in the interest of health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately provide beds at the County Jail needed by the City of Fairlawn to house City prisoners.
