A Resolution authorizing the County Executive to execute an agreement with the Ohio Department of Transportation to undertake improvements to Canton Road at the intersection of US 224 and State Route 91, in Springfield Township and the Village of Lakemore, in Council District 8, at an estimated cost to the County not to exceed \$771,148.32, requesting the Director of Transportation to proceed with the project, and appropriating funds, for the Engineer, and declaring an emergency.

WHEREAS, the Ohio Department of Transportation ("ODOT") and the County Engineer have identified the need for widening and safety improvements along Canton Road (County Route 66) at the intersection of US 224 and State Route 91, Project Identification No. 89113 (the "Project"); and

WHEREAS, the County owns and maintains the southern leg of the above referenced intersection and ODOT owns and maintains the northern, eastern, and western legs of the intersection; and

WHEREAS, pursuant to Resolution 2018-015, adopted on January 29, 2018, this council authorized the County's participation in the Project with the understanding that the Project will be administered by ODOT; and

WHEREAS, following adoption of the aforementioned Resolution, the Ohio Director of Transportation has caused to be made detailed plans and specifications and an estimate of cost and expense for undertaking the Project, and has transmitted copies of same to the County Engineer; and

WHEREAS, the estimated cost of the County's portion of the Project is \$771,148.32, and the agreement with ODOT for undertaking the Project provides that County's costs shall be adjusted based on actual costs of the Project; and

WHEREAS, pursuant to the agreement with ODOT, the County agrees to assume and bear one hundred percent (100%) of the entire cost of the County-owned portion of the Project, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of the Project from funds allocated by the Federal Highway Administration, U.S. Department of Transportation; and

WHEREAS, ODOT has requested final authorizing legislation giving the Ohio Director of Transportation the authority to proceed with the Project as designed, and further authorizing the County Executive to execute the agreement with ODOT to undertake the Project and to provide payment of the agreed upon portion of the cost of the Project; and

WHEREAS, it is necessary to appropriate funds for said agreement in an amount not to exceed \$771,148.32; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute an agreement with the Ohio Department of Transportation to undertake the Project, and to further and request the Ohio Director of Transportation to proceed with the Project as designed.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

#### SECTION 1

The County Executive is hereby authorized to execute an agreement with the Ohio Department of Transportation to undertake the improvements to Canton Road at the intersection of US 224 and State Route 91, in Springfield Township and the Village of Lakemore, in Council District 8 (the "Project"), at an estimated cost to the County not to exceed \$771,148.32, a copy of which is attached hereto as Exhibit A and incorporated fully herein, with such modifications and revisions as shall be in furtherance of the provisions of said contract, and not substantially adverse to the County, all of which shall be conclusively evidenced by the execution thereof by the County Executive.

## **SECTION 2**

Funds are hereby appropriated as follows:
