7 **A Resolution authorizing the County Executive to advertise for bids for the Summit**  
8 **County Jail Roof Replacement Project, located in the City of Akron, in Council District 4,**  
9 **for an estimated total cost not to exceed \$2,900,000.00, for the County Executive's**  
10 **Department of Administrative Services–Physical Plants, and declaring an emergency.**

11  
12 WHEREAS, the existing roof on the Summit County Jail, located in the City of Akron, in  
13 Council District 4, which was installed in two phases, 26 and 33 years ago, respectively, is in  
14 poor shape and accordingly needs to be replaced; and

15  
16 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
17 requires this Council's authorization for the County Executive to advertise for bids; and

18  
19 WHEREAS, the County Executive wishes to advertise for bids for the aforementioned  
20 replacement roof, the Summit County Jail Roof Replacement Project, for an estimated total cost  
21 not to exceed \$2,900,000.00; and

22  
23 WHEREAS, the Summit County Jail Roof Replacement Project was approved as part of  
24 the Capital Improvements Program for 2020-2025 by Resolution No. 2020-027; and

25  
26 WHEREAS, a copy of the bid specifications are on file in the Clerk of Council's Office;  
27 and

29 WHEREAS, it is expected that the cost of said project will be reimbursed through the  
30 issuance of general obligation bonds at a future date; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that is necessary and in the best interest of the County of Summit to authorize the County  
34 Executive to advertise for bids for Summit County Jail Roof Replacement Project, for an  
35 estimated total cost not to exceed \$2,900,000.00;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that;

42 The County Executive is authorized to advertise for bids Summit County Jail Roof  
43 Replacement Project, located in the City of Akron, in Council District 4, for an estimated total  
44 cost not to exceed \$2,900,000.00.

46 SECTION 2

48 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
49 of the residents of the County of Summit, and for the further reason that it authorizes the County  
50 Executive to immediately advertisement for bids for a necessary new roof for the Summit  
51 County Jail.


