7 **A Resolution pursuant to Section 169.04(i) of the Codified Ordinances of the County of**
8 **Summit, entitled “Temporary Hiring Freeze” to authorize the Sheriff to hire one**
9 **bargaining unit Inmate Service Worker I at the base rate of \$15.61 per hour, as a**
10 **replacement, for the Sheriff, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Ordinance No. 2020-095, which enacted
13 Section 169.04(i) of the Codified Ordinances of the County of Summit, entitled, “Temporary
14 Hiring Freeze,” due to the anticipated economic crisis and related budgetary concerns resulting
15 from the Coronavirus Disease 2019 (“COVID-19”) pandemic; and

16
17 WHEREAS, Section 169.04(i) provides that if a County office is able to demonstrate that
18 the filling of an existing position by hiring an employee is necessary for the effective and
19 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
20 said employees; and

21
22 WHEREAS, three bargaining unit Inmate Service Workers I’s have left or will be leaving
23 County employment within the next three months, and the Sheriff’s Office needs to replace one
24 of these positions, as Inmate Service Worker I’s are critical positions for the operations of the
25 Sheriff’s Office by maintaining programming for inmates housed at the Summit County Jail; and

27 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
28 is necessary and in the best interest of the County of Summit to authorize the Sheriff to hire an
29 Inmate Servicer Worker I, at the base rate of \$15.61 per hour;

31 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
32 State of Ohio, that:

36 This Council hereby determines that the Sheriff has demonstrated that it is necessary for
37 the effective and continued operation of his office to authorize the Sheriff, pursuant to Section
38 169.04(i) of the Codified Ordinances of the County of Summit, to hire one bargaining unit
39 Inmate Service Worker I, Classification S2701, at a base rate of pay of \$15.61 an hour.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit and for the further reason to immediately
45 authorize the Sheriff to hire and train an Inmate Service Worker I in order to continue inmate
46 programming at the Summit County Jail.



16 121.22 of the Ohio Revised Code.


