A Resolution confirming an award by the Board of Control of a renewal (second and final) of a professional service contract with AccordWare, LLC, for online benefit enrollment services through its BenXpress enrollment system, for a one-year term, from 8/1/20 through 7/31/21, in an amount not to exceed \$121,000.00, for the Executive, and declaring an emergency.

WHEREAS, the County requested proposals from 13 vendors through the Division of Purchasing for online employee benefit enrollment services; and

WHEREAS, after receiving proposals from 5 vendors, AccordWare, LLC submitted the lowest responsive and responsible proposal, and the County's insurance consultant, NFP Corporate Services (OH), recommended that the County enter into a professional service contract with AccordWare, LLC, for online employee benefit enrollment services through its BenXpress system, for a one-year term, from 8/1/18 through 7/31/19, in an amount not to exceed \$121,000.00, with two options to renew for an additional one-year term; and

WHEREAS, this Council previously adopted Resolution No. 2018-247, which authorized the Executive to execute, subject to the approval of the Board of Control, said professional service contract with AccordWare, LLC; and

WHEREAS, the County wishes to enter into a second and final renewal of said professional service contract with AccordWare, LLC; and

WHEREAS, the Board of Control, at its meeting held August 19, 2020, awarded a renewal (second and final) for a professional service contract with AccordWare, LLC, for online benefit enrollment services through its BenXpress enrollment system, for a one year term, 8/1/20 through 7/31/21, in an amount not to exceed \$121,000.00, subject to confirmation by this Council; and

WHEREAS, this Council has determined by reviewing all pertinent information that the aforementioned renewal (second of two) of a professional service contract with AccordWare, LLC is necessary and in the best interest of the County of Summit;
