A Resolution, pursuant to Section 169.04(i) of the Codified Ordinances of the County of Summit, entitled "Temporary Hiring Freeze," to authorize the County Executive to hire a Fiscal Officer, for the County Executive, and declaring an emergency.

WHEREAS, this Council previously adopted Ordinance No. 2020-095, which enacted Section 169.04(i) of the Codified Ordinances of the County of Summit, entitled, "Temporary Hiring Freeze," due to the anticipated economic crisis and related budgetary concerns resulting from the COVID-19 pandemic and the State of Ohio's Stay at Home Order; and

WHEREAS, Section 169.04(i) provides that if a County office is able to demonstrate that the filling of an existing position by hiring an employee is necessary for the effective and continued operation of the office, Council may adopt a Resolution authorizing the office to hire said employees; and

WHEREAS, an employee in the position of Fiscal Officer, a non-bargaining unit position in the Summit County Department of Finance and Budget, will be on extended leave, necessitating the filling of another existing vacancy; and

WHEREAS, because of the critical functions of said position, it is necessary for the County Executive to fill the vacated Fiscal Officer position in order for the Summit County Department of Finance and Budget to operate effectively and efficiently; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to hire a new Fiscal Officer;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

County Council hereby determines that the County Executive has demonstrated that it is necessary for the effective and continued operation of the Summit County Department of Finance and Budget to authorize, pursuant to Section 169.04(i) of the Codified Ordinances, the hiring of a new Fiscal Officer.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to immediately authorize the County Executive to hire a new Fiscal Officer at the Summit County Department of Finance and Budget to fill a vacancy.
