7 **A Resolution authorizing the Executive to execute an Ohio Public Works Commission**
8 **grant application and any other necessary documents, with the City of Macedonia as lead**
9 **applicant, for the Highland Road Phase II Resurfacing Project in the City of Macedonia**
10 **and Twinsburg Township, in Council District 1, at a cost to the County not to exceed**
11 **\$118,000.00, for the Engineer, and declaring an emergency.**

12
13 WHEREAS, the Engineer concludes that there is a public need to improve Highland
14 Road from Valley View Road east to the Twinsburg Township corporate line in the City of
15 Macedonia and Twinsburg Township, Council District 1; and

16
17 WHEREAS, the Highland Road Resurfacing Phase II Project (“the Project”), involves a
18 split jurisdiction, with the City of Macedonia owning and maintaining 85% of the road involved
19 in the Project and the County of Summit owning and maintaining 15% of the road involved in
20 the Project; and

21
22 WHEREAS, the County of Summit is eligible, with the City of Macedonia as lead
23 applicant, to acquire Ohio Public Works Commission Local Transportation Improvement
24 Program (“LTIP”) grant funds for the Project; and

26 WHEREAS, this Council has determined by reviewing all pertinent information, that it is
27 necessary and in the best interest of the County to apply for said funds, to authorize the
28 expenditure of up to \$118,000.00 in County local matching road and bridge funds for said
29 improvement and to authorize the Executive to execute a grant application and associated
30 documents for the Project;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

35 SECTION I

36
37 The Executive is hereby authorized to execute an Ohio Public Works grant application
38 and any other documents necessary to accept and administer a grant for Ohio Public Works
39 Commission Local Transportation Improvement Program (“LTIP”) funds, in an amount not to
40 exceed \$118,000.00, for the purpose of resurfacing Highland Road from Valley View Road east
41 to the Twinsburg Township corporate line in the City of Macedonia and Twinsburg Township,
42 Council District 1 (the “Project”). The payment to Macedonia or directly to the contractor hired
43 for the Project of an amount not to exceed \$118,000.00 in County local matching road and bridge
44 funds as the County’s share of the cost of the Project is hereby authorized.

6 The Clerk of Council is instructed to provide two certified copies of this Resolution to the
7 Engineer, for submission to the Ohio Public Works Commission with said grant application.

9 SECTION 3

11 This Resolution is hereby declared an emergency in the interest of the health, safety and
12 welfare of the residents of the County of Summit, and for the further reason that it will allow the
13 County to obtain grant funds for an immediately needed improvement project.

15 SECTION 4

17 Provided this Resolution receives the affirmative vote of eight members, it shall take
18 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
19 effect and be in force at the earliest time provided by law.

21 SECTION 5

23 It is found and determined that all formal actions of this Council concerning and relating
24 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
25 deliberations of this Council and of any of its committees that resulted in such formal action,
26 were in meetings open to the public, in compliance with all legal requirements, including Section
27 121.22 of the Ohio Revised Code.
