12 WHEREAS, the Board of Control, at its meeting held February 3, 2016 awarded a
13 purchase contract to Cargill Incorporated for road salt for the 2016 snow and ice control season,
14 under CUE pricing, in an amount not to exceed \$740,000.00, subject to confirmation by County
15 Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned purchase contract with Cargill Incorporated is necessary and in the best
19 interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a purchase contract with Cargill Incorporated for

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for road salt for the 2016 snow and ice control season.

40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.




