A Resolution appropriating funds, in the amount of \$8,562,984.00, from a tax levy for the Akron Zoological Park for tax year 2015/collection year 2016, for the Department of Finance and Budget, and declaring an emergency.

WHEREAS, on November 5, 2013, Summit County voters approved Issue 3, a renewal tax levy for the purpose of operating and capital expenses for the provision and maintenance of zoological park services and facilities at the Akron Zoo at a rate not exceeding eight-tenths (0.8) mill for each one dollar of valuation, which amounts to eight cents (\$0.08) for each one hundred dollars of valuation, for a period of seven years, beginning on the tax list and duplicate for the year 2014, the proceeds of which would be first distributed to the County in 2015; and

WHEREAS, it is necessary to appropriate said tax levy funds, in the amount of the \$8,562,984.00, from said tax levy for tax year 2015/collection year 2016; and
