7 **An amended Resolution** authorizing the County Executive to execute a 60-month
8 **lease/purchase agreement with Graphic Enterprises Office Solutions, Inc., De Lage Landen**
9 **Public Finance, LLC, subject to the approval of the Board of Control, for office equipment**
10 **and software licenses supplied by Graphic Enterprises Office Solutions, Inc., in an amount**
11 **not to exceed \$74,700.00, for the Prosecutor, and declaring an emergency.**

13 WHEREAS, the a lease with Graphic Enterprises Office Solutions, Inc., which is being
14 financed through De Lage Landen Public Finance, LLC, is exempt from competitive bidding as a
15 contract for equipment through participation in a contract which the Ohio Department of
16 Administrative Services has entered into pursuant to Section 125.04 of the Ohio Revised Code
17 and Section 177.06 of the Codified Ordinances of the County of Summit; and

19 WHEREAS, the County wishes to enter into a 60-month lease/purchase agreement with
20 De Lage Landen Public Finance, LLC ~~Graphic Enterprises Office Solutions, Inc.~~, for 7 Xerox
21 copiers, 5 printers, and 2 software licenses supplied by Graphic Enterprises Office Solutions,
22 Inc., subject to the approval of the Board of Control, approved by the Information Technology
23 Board on 3/10/16, in an amount not to exceed \$74,700.00; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned lease/purchase agreement with ~~Graphic Enterprises Office Solutions,~~
27 Inc. De Lage Landen Public Finance, LLC is necessary and in the best interest of the County of
28 Summit;

35 The County Executive is hereby authorized to execute a 60-month lease with ~~Graphic~~
36 ~~Enterprises Office Solutions, Inc.~~, De Lage Landen Public Finance, LLC, subject to the approval
37 of the Board of Control, for 7 Xerox copiers, 5 printers, and 2 licenses software supplied by
38 Graphic Enterprises Office Solutions, Inc., approved by the Information Technology Board on
39 3/10/16, in an amount not to exceed \$74,700.00. The Executive is further authorized to execute
40 any other necessary documents, subject to the approval of the Board of Control, with De Lage
41 Landen Public Finance, LLC and/or Graphic Enterprises Office Solutions, Inc. for the
42 lease/purchase of said equipment and software.

46 This Resolution is hereby declared an emergency in the interest of the health, safety, and
47 welfare of the citizens of the County of Summit, and for the further reason to immediately
48 provide for a necessary lease for Xerox copiers, printers, and software for the Prosecutor.
