8 **with DeLage Landen Public Finance, LLC through Graphic Enterprises Office Solutions,**
9 **Inc., subject to the approval of the Board of Control, for office equipment and software**
10 **licenses, in an amount not to exceed \$55,980.00, for the Prosecutor- Child Support**
11 **Enforcement Agency, and declaring an emergency.**

13 WHEREAS, the lease ~~with acquisition of copiers through~~ Graphic Enterprises Office
14 Solutions, Inc. is exempt from competitive bidding as a contract for equipment through
15 participation in a contract which the Ohio Department of Administrative Services has entered
16 into pursuant to Section 125.04 of the Ohio Revised Code and Section 177.06 of the Codified
17 Ordinances of the County of Summit; and

19 WHEREAS, the County wishes to enter into a 60-month lease with DeLage Landen
20 Public Finance, LLC through Graphic Enterprises Office Solutions, Inc., for to finance 6 Xerox
21 copiers, 5 printers, and 2 software licenses, subject to the approval of the Board of Control,
22 approved by the Information Technology Board on 3/10/16, in an amount not to exceed
23 \$55,980.00; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned lease with ~~Graphic Enterprises Office Solutions, Inc.~~ DeLage Landen
27 Public Finance, LLC is necessary and in the best interest of the County of Summit;

34 The County Executive is hereby authorized to execute a 60-month lease with DeLage
35 Landen Public Finance, LLC through Graphic Enterprises Office Solutions, Inc., subject to the
36 approval of the Board of Control, for 6 Xerox copiers, 5 printers, and 2 licenses software,
37 approved by the Information Technology Board on 3/10/16, in an amount not to exceed
38 \$55,980.00. The Executive is further authorized to execute any other necessary documents,
39 subject to the approval of the Board of Control, with De Lage Landen Public Finance, LLC
40 and/or Graphic Enterprises Office Solutions, Inc. for the lease of said equipment and software.

44 This Resolution is hereby declared an emergency in the interest of the health, safety, and
45 welfare of the citizens of the County of Summit, and for the further reason to immediately
46 provide for a necessary lease for Xerox copiers, printers, and software for the Prosecutor's- Child
