WHEREAS, County Council previously adopted Resolution No. 2015-472, which authorized the County Executive to execute a Communications System Agreement, Equipment Lease-Purchase Agreement and System Upgrade Agreement with Motorola Solutions, Inc., pursuant to which the County purchased and leased, and Motorola has proceeded to install, upgrade and maintain a new Motorola ASTRO 25 radio communications equipment, components and radios that are necessary to upgrade the Original System to an APCO P25-compliant radio system; and
