7 **A Resolution authorizing the County Executive to advertise for bids for the purchase of**  
8 **twenty supplied air respirator units, for an estimated cost not to exceed \$63,748.00, for the**  
9 **Executive's Department of Law, Insurance, and Risk Management- Division of Emergency**  
10 **Management, and declaring an emergency.**

11  
12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the County Executive to advertise for bids; and

14  
15 WHEREAS, the County Executive wishes to advertise for bids for the purchase of twenty  
16 supplied air respirator units, for the Summit County Special Operations Response Team,  
17 Technical Rescue and Hazardous Materials Branch, to support the mitigation of the effects of  
18 weapons of mass destruction, chemical, biological, radiological, nuclear, and explosive incidents,  
19 for an estimated cost not to exceed \$63,748.00; and

21 WHEREAS, a copy of the bid specifications are attached as Exhibit A; and

23 WHEREAS this Council finds and determines, after reviewing all pertinent information  
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
25 advertise for bids for the aforementioned supplied air respirator units;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
28 of Ohio, that:

32 The County Executive is authorized to advertise for bids for the purchase of twenty  
33 supplied air respirator units, for the Summit County Special Operations Response Team,  
34 Technical Rescue and Hazardous Materials Branch, to support the mitigation of the effects of  
35 weapons of mass destruction, chemical, biological, radiological, nuclear, and explosive incidents,  
36 for an estimated cost not to exceed \$63,748.00.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and  
41 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the  
42 Executive to immediately advertise for bids for the necessary supplied air respirator units.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.
