A Resolution confirming an award by the Board of Control of a renewal (first of four) of a purchase contract with Aramark Correctional Services, LLC, for detention center youth food services, for the period 7/1/16 through 6/30/17, for a total amount not to exceed \$250,000.00, for the Court of Common Pleas-Juvenile Division, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2015-263, which confirmed an award by the Board of Control of a purchase contract with Aramark Correctional Services, LLC, for detention center youth food services, for the period 7/1/15 to 6/30/16, with four options to renew for a one-year period, in an amount not to exceed \$2.869 per meal and \$.50 per snack, for a total estimated amount not to exceed \$300,000.00, for the Court of Common Pleas-Juvenile Division; and

WHEREAS, the Board of Control, at its meeting held June 8, 2016, awarded a renewal (first of four) of a purchase contract to Aramark Correctional Services, LLC, for detention center youth food services, for the period 7/1/16 through 6/30/17, in an amount not to exceed \$2.946 per meal and \$.513 per snack, for a total amount not to exceed \$250,000.00, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned renewal of a purchase contract with Aramark Correctional Services LLC is necessary and in the best interest of the County of Summit;
