7 **A Resolution adjusting existing appropriations in the amount of \$170,000.00 within the**  
8 **2016 Summer Youth Employment Program grant, for the Executive’s Department of Job**  
9 **and Family Services, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2016-118, which authorized  
12 the County Executive to execute any documents necessary to accept an award from the Ohio  
13 Department of Job and Family Services of a 2016 Summer Youth Employment Program grant of  
14 Temporary Assistance for Needy Families funds, for the period 5/1/16 through 8/31/16, in the  
15 amount of \$1,960,706.00, with no local match requirement, and appropriating grant funds; and

17 WHEREAS, the Executive’s Department of Human Resources employs supervisors to  
18 provide enhanced oversight at youth worksites and assistance with timesheet collection/review  
19 for submission for the 2016 Summer Youth Employment Program; and

21 WHEREAS, it is necessary to adjust existing appropriations, in the amount of  
22 \$340,000.00, in order to meet the needs of the employment costs of the supervisors of the 2016  
23 Summer Youth Employment Program; and

25 WHEREAS, this Council finds and determines after reviewing all pertinent information,  
26 that the adjustment of existing appropriations, in the amount of \$170,000.00, is necessary and in  
27 the best interest of the County of Summit;

SECTION 4




