12 WHEREAS, the Board of Control, at its meeting held June 1, 2016, awarded professional
13 service contracts with certain providers for behavioral health and juvenile justice services, for the
14 period 7/1/16 through 6/30/17, in an amount not to exceed \$249,500.00, subject to confirmation
15 by County Council ; and

17 WHEREAS, a list of providers is attached as Exhibit A; and

19 WHEREAS, this Council finds and determines after reviewing all pertinent information,
20 that the aforementioned professional service contracts with certain providers are necessary and in
21 the best interest of the County of Summit;

28 The award by the Board of Control of professional service contracts with certain
29 providers for behavioral health and juvenile justice services, as set forth in Exhibit A, attached
30 to this Resolution and incorporated herein as if fully restated, for the period 7/1/16 through
31 6/30/17, in an amount not to exceed \$249,500.00, is hereby authorized and the County Executive
32 is hereby authorized to execute the aforementioned professional service contracts.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further reason to immediately
38 provide for behavioral health and justice services to the Court of Common Pleas - Juvenile






