8 **Control, a renewal (second and final) of a professional service contract with AllOne Health**
9 **Resources, Inc. (Ease@Work) for Employee Assistance Program services for County**
10 **employees and employees of other participating political subdivisions, for a one-year term,**
11 **from 1/1/21 through 12/31/21, for an amount not to exceed \$123,452.00, for the Executive's**

15 WHEREAS, this Council previously adopted Resolution No. 2018-321, which confirmed
16 the award by the Board of Control of a professional service contract with The Centers for
17 Families and Children d.b.a. Ease@Work for Employee Assistance Program ("EAP") services
18 for County employees and employees of other participating political subdivisions, for a one-year
19 term, from 1/1/19 through 12/31/19, with two options to renew for an additional one-year term,
20 for an amount not to exceed \$18.30 per employee per year, for a total amount not to exceed
21 \$123,452.00; and

23 WHEREAS, this Council subsequently adopted Resolution No. 2019-321, which
24 approved the assignment of the professional service contract between the County and The
25 Centers for Families and Children d.b.a. Ease@Work for EAP services to AllOne Health
26 Resources Inc., including the two renewals of said contract approved by Resolution No. 2018-
27 321; and

29 WHEREAS, it is necessary to authorize the Executive to execute, subject to the Board of
30 Control, a renewal (second and final) of a professional service contract with AllOne Health
31 Resources, Inc. (Ease@Work) for EAP services for County employees and employees of other
32 participating political subdivisions, for a one-year term, from 1/1/21 through 12/31/21, for an
33 amount not to exceed \$18.30 per employee per year, for a total amount not to exceed
34 \$123,452.00; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that it is necessary and in the best interest of the County to authorize the Executive to execute,
38 subject to the approval of the Board of Control, the aforementioned renewal (second and final) of
39 a professional service contract with AllOne Health Resources, Inc.;

SECTION 2
