7 **A Resolution appropriating carryover balances for various grants and special revenue**
8 **funds for 2021 as set forth in Exhibit A, for the Executive's Department of Finance and**
9 **Budget, and declaring an emergency.**

11 WHEREAS, the Court of Common Pleas – Juvenile Division, the Prosecutor, the
12 Sheriff, the Court of Common Pleas, Job and Family Services and the Executive's
13 Departments of Development, Public Safety and Emergency Management have grant funds
14 which were previously appropriated in 2020 and now require the appropriation of their
15 unspent and unencumbered grant balances for use in 2021; and

17 WHEREAS, it is necessary to appropriate these carryover funds from 2020 to meet
18 obligations for the balance of the 2021 calendar year as set forth in Exhibit A, attached to
19 this Resolution and incorporated herein as if fully restated; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent
22 information, that it is necessary and in the best interest of the County of Summit to
23 appropriate the aforementioned carryover funds;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit,
26 State of Ohio, that:

30 The County Fiscal Officer is hereby authorized and directed to effect the
31 appropriations set forth in Exhibit A, attached to this Resolution and incorporated herein as
32 if fully restated.

36 This Resolution is hereby declared an emergency in the interest of the health, safety
37 and welfare of the residents of the County of Summit and for the further reason to provide
38 for the necessary appropriations for the Court of Common Pleas – Juvenile Division, the
39 Prosecutor, the Sheriff, the Court of Common Pleas and the Executive's Departments of
40 Development, Public Safety and Emergency Management carryover grants and special
41 revenue funds as forth in Exhibit A, attached to this Resolution and incorporated herein as if
42 fully restated.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.


