A Resolution authorizing the Executive to execute a grant agreement with the Summit County Combined General Health District d.b.a. Summit County Public Health, for a grant, in an amount not to exceed \$600,000.00, for the period from 3/1/20 through 12/31/21 to provide for COVID related capital improvements at Health District facilities, for the Executive, and declaring an emergency.

WHEREAS, the Coronavirus Disease 2019 (COVID-19) has had and will continue to have a significant impact on the health and wellbeing of the residents of Summit County, and has created a need to make certain alterations and improvements to facilities to ensure the safety of the employees in and users of those facilities; and

WHEREAS, Summit County Combined General Health District d.b.a. Summit County Public Health ("Summit County Public Health"), an agency that provides many critical health services to members of the community, has made and will continue to make changes to its facilities and operations ("Capital Improvements") in order to provide these services in an environment that is safe for its employees and clients; and

WHEREAS, Summit County Public Health has identified certain capital facility projects to address COVID Safety, including Vitals self-service kiosks, installation of badge readers for employee access areas, plexiglass shields for public access areas, installation of exterior door from Laboratory, installation of exterior walk-up window in Vitals Department, ion filtration installation at Fairway facility, and equipment for wireless network upgrades; and

WHEREAS, the Executive has agreed to provide County general capital improvement funds made available to the County as a result of the use of CARES Act funds for certain COVID-19 operations of the County in 2020; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute a grant agreement with Summit County Public Health to provide capital improvement funds from the County's General Capital Improvement Fund in the amount of \$600,000.00 for the period from 3/1/2020 through 12/31/2021.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## **SECTION 1**

The Executive is hereby authorized to execute a grant agreement with the Summit County Combined General Health District d.b.a. Summit County Public Health in an amount not to exceed \$600,000.00, for the period from 3/1/2020 through 12/31/2021 to provide funds from the County's General Capital Improvement Fund to provide for COVID related capital improvements necessary at Summit County Public Health Facilities.

## **SECTION 2**

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be in force at the earliest time provided by law.

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with legal requirements, including Section 121.22 of the Ohio Revised Code.
