A Resolution amending Resolution No. 2018-221, subject to the approval of the Board of Control, to increase the County's local cash match in the Prospect Street Reconstruction Project Q-953-2, in the Village of Mogadore, in Council District 8, from an amount not to exceed \$75,000.00 to an amount not to exceed \$139,944.18, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, this Council previous adopted Resolution No. 2018-221, which authorized the Executive to execute any agreements, memorandums of understanding or other documents necessary to participate with the Village of Mogadore in applying for Ohio Public Works Commission funding for the Prospect Street Reconstruction Project Q-953-2 (the "Project"), at a cost to the County not to exceed \$75,000.00, located in the Village of Mogadore, in Council District 8; and

WHEREAS, while completing the Project, it was determined that an additional four hundred sixty-four (464) linear feet of 8" gravity sanitary sewer would need to be replaced with 10" gravity sanitary sewer to comply with Ohio EPA standards for wastewater facilities to improve water flow and eliminate ground water infiltration; and

WHEREAS, due to the modifications of Project's sanitary sewer work, the Project's total completion cost increased from \$150,00.00 to \$279,888.36, which increased the County's local cash match for its portion of the Project from \$75,000.0 to \$139,944.18; and

WHEREAS, the County's local match for the Project is to be paid directly to the Village of Mogadore from the Executive's Department of Sanitary Sewer Services' Sanitary Sewer Enterprise Funds; and
